DRUG AND GANG ABSTENTION AGREEMENT

THE PERSONAL USE, POSSESSION, SALE, MANUFACTURE OR DISTRIBUTION OF ILLEGAL DRUGS OR THE PARTICIPATION IN ILLEGAL GANG ACTIVITY BY APPLICANTS FOR, OR RESIDENTS OF; Federally or State Funded assisted housing, which includes, but is not limited to; Low-Income Public Housing, Section 8 Housing, USDA Rural Development Program or the State of California Rental Housing Construction Program, IS STRICTLY PROHIBITED.

The applicant(s)/resident(s)/participant(s) state that we, nor any member of our household are current users of illegal drugs or participating in illegal gang activity and AGREE we will not use, possess, sell, manufacture, or distribute any illegal drugs or participate in illegal gang activity.

We understand that should we, any member of our household or guest violate this agreement, the Housing Authority of the County of Kern and/or Landlord may TERMINATE OUR TENANCY.

BY SIGNING THIS AGREEMENT WE CERTIFY THAT WE UNDERSTAND THE ABOVE, HAVE BEEN GIVEN THE OPPORTUNITY TO DISCUSS IT WITH THE LANDLORD OR HOUSING AUTHORITY STAFF, AND HAVE BEEN ADVISED THIS AGREEMENT IS A PART OF OUR ASSISTED HOUSING RESIDENTIAL LEASE OR PROGRAM OBLIGATION.
